Instructions for Authors

Papers will be accepted in English language only. Each paper must have a standard structure – introduction, literature review, research methodology, data, empirical results, conclusion and references.

There are two publications options for conference participants: a) standard conference proceeding with ISBN (will be sent for inclusion in to the CPCI), b) paper in a scientific journal Acta academica karviniensia.

All papers presented on the conference will be considered for the “Best papers awards”. Three of them will receive a voucher for editorial fee (500 EUR) of journal E&M Economics and Management (IF 1.163).

Papers in accordance with formal requirements will be accepted only. After extended abstract acceptance and conference fee payment send your papers no later than **31st August 2018** to: hpeu2018@opf.slu.cz, with a subject: CONFERENCE. Papers submitted after this date will not be submitted to the review process and will not be published.
